Physical Education Activity Program Overview.

The Physical Education Activity (PEA) program offers a wide variety of activity-based courses that meet Appalachian State's General Education Wellness Literacy requirements.

The PEA program is regarded by many as one of the best in higher education. On average, the program offers over 170 courses in more than 40 activity areas per semester and serves thousands of students annually. The program is supported by over 30 outstanding faculty who are capable of and committed to providing exceptional educational experiences empowering students to pursue a lifetime of activity.

PEA courses are based on the National Association of Sport and Physical Education (NASPE) guidelines for appropriate practice in college/university physical activity instruction programs.

Instructor Checklists.

1. Post a welcome message on the News & Announcements on AsULearn: Note the meeting location, meeting dates, introduce yourself, remind them to bring their ID (Quinn/SRC), and provide a course overview. Consider messaging your second half course students and reminding them of the class start date.

AsULearn-course pages automatically become active/visible on the first day of that course. Students will NOT receive AsULearn announcements if the course is not visible, for example, second half courses may not be visible on day 1 of the semester (change to visible manually before posting a News message).

2. Contact the equipment manager about any equipment you need for this semester.

3. Provide students with a syllabus. Either via AsULearn or paper. The HCC front desk staff can make copies for you. Use PDF format when emailing the syllabus for copies or posting on AsULearn.

4. Look up your class rosters online before AND after drop/add-record their names. Record attendance, class topics, student behavior, etc., in your class record book or on AsULearn. Keep these records for at least 1 year.
If students are attending, but are not on your roster, they may be in another section.

5. Do not sign or approve late adds or course cap overrides without approval of the PEA Director.

6. Have any student with a medical concern complete the Medical Information form keep these with you at all times in class. Inform the PEA Director of any significant medical issues. Outdoor courses should collect more in-depth medical information on the Medical Extended Trips form from every student.

7. Fitness Assessment-Talk to your students about the purpose of the assessments and the HFZ on the back.

8. Notify the PEA Director if you need to miss/cancel class (does not apply when App cancels all classes).

9. Complete an accident report and submit to PEA Director for ANY accident/incident. This applies even if there is no visible injury. This is separate from the UREC accident report.

10. Do not give the exam/fitness tests or have assignments due on the final day of class. If a student misses class or classes are cancelled it will be very difficult to track them down.

11. Connect your ASU laptop to the Ethernet (hardwire) once every 2 months to renew the software license.

12. Link the course evaluation on your AsULearn page. Use class time to allow students to complete the course evaluations online on their phones.

Emergencies:

- 1. Carry a CPR mask and student medical forms with you.
 - Ask if you need a CPR mask or class record book.

Additional Items for Off-Campus Outdoor Courses

1. Courses meeting outside of regular semester dates (ex. winter break) must fill out: Academic Course Meeting Dates Exception form and email it to the director prior to the start of the semester. Submit with schedule in semester prior.

2. Travel forms for PEA course trips are typically filled out by the PEA Director.

3. Post a message reminding students of the trip dates multiple times prior to the start of the semester. You can schedule these messages in AsULearn News & Announcements-add a new topic-advanced-display period. The AsULearn page must be visible to students for the message to go out (Quickset on right).

4. Ensure you have a first aid kit and that it is up to date at least 1 month prior to your first trip.

5. Ensure you locate all the equipment for your course in advance. Do you know the lock combinations? Overnight instructors should ensure there is enough stove fuel at least 2 weeks prior to the trip date.

6. All students in off-campus courses should complete the **RMPE Medical Extended Trips form**.

7. Complete a Risk Plan-examples/templates are available from the PEA Director. Save emergency contacts from this manual in your phone.

8. If traveling overnight-complete the Student Development Travel form online.

9. Complete the UREC Outdoor Programs Equipment Request form (excel file) if your students need to check out gear for a trip. Submit to OP at least 1 week prior to the trip. There will be no cost for equipment check out. Faculty can also check out Program Gear when needed. (form is on RMPE website-faculty/staff resources)

10. Ensure your Risk Manager(s) complete the necessary paperwork with the RMPE Department. Ensure your Risk Manager(s) complete paper and electronic timesheets on time. Risk Managers also need a travel authorization, which should be completed with the RMPE admin assistant during the hiring process. If you have questions contact the RMPE Administrative Assistant-262-3149.

11. Check your course destinations. Is the Parkway open? Prescribed burns? Lakes drained?

12. Instructors should cover potential risks with students in writing and verbally.

13. Notify the PEA Director immediately of any accidents or near misses.

Academic Integrity Code. See also Syllabus Policy Statements

Appalachian's policy on academic integrity allows a student and faculty member to work out sanctions for a first offense without a formal referral to the Office of Student Conduct. However, this policy works only if the process outlined in the Code is followed, which includes a record of the sanction submitted to the Office of Student Conduct on the appropriate form.

Accidents. See also Emergencies and Medical Withdrawal (Drop)

Faculty should file an accident report (send to PEA Director) for all accidents, even those that do not result in injury.

Instructor should email the Medical Withdrawal info. (Dropping a course) to students injured in class.

Emergency Contacts (See also Emergencies/Risk Management)

After emergency services have been contacted inform department administrators of any serious injury. See also "Emergencies" section for contact information.

Medical treatment should be administered by trained personnel. Students with non-life threatening injuries should be referred to the Student Health Center or local walk in clinics.

After all necessary medical treatment has been administered, accidents involving any loss of blood, loss of consciousness, or medical treatment should be reported immediately to the PEA Director by calling, texting, or emailing. As soon as possible the instructor should email details/accident report form. The PEA Director will file the accident report with the Safety Office and retain a copy.

Accident Report Information: Name, DOB, ASU ID#, Address, Phone, Date, Time, Location of Accident. Accident Report should be filled out within 48 hours by the instructor. Electronic form is available on the RMPE website

Appalachian does not provide insurance or pay students' medical costs if they are injured in class. Students can visit Health Services (262-6577) on campus, but there is a limit to the care they are able to provide.

Injuries to University Employees

Employees who are injured while at work should report the injury to the PEA Director immediately via phone and email. Supervisor's Accident Report-fill out within 24 hours.

Used to notify ASU Human Resource Services and Environmental Health, Safety, & Emergency Management personnel about an on-the-job injury. Form link is on the right side of the webpage.

From Student Development Office

In the event student workers, faculty or staff members suffer a work-related injury or illness in conjunction with approved field trips or other excursions, Workers' Compensation forms (available under the Workers' Compensation heading on the Safety & Workers' Compensation Office website, at: http://www.busaf.appstate.edu/safety/workerscomp.html

Must be completed and forwarded to the Safety & Workers' Comp. Office within 24 hrs. of occurrence. Contact the Safety & Workers' Compensation Office at 828-262-4008 if you have questions.

Vehicle Accidents

Vehicle accidents involving damage to university vehicles, damage to other vehicles or objects, or injury to any person should be reported to local law enforcement as well ASU Police and the Motor Pool and the PEA Director by calling 336-749-5993 and via email. Employees should get the Accident Report Number from the law enforcement officer.

Accident Information

ANY requests for information related to the accident from persons outside of the university should be referred to the Director for more information. The instructor should also notify the PEA Director if they receive any requests for information.

Do not provide information on participants' names/personal information, activities, or possible injuries. The following statement can be effective: *"We are trying to gather information so that we can fully understand what happened. Please contact the PEA Director who will be able to give you more information."*

AEDs/CPR Mask/Gloves.

Faculty members should carry their CPR mask and gloves with them while on campus.

AppalCart is the transportation authority serving all of Watauga County with ten bus routes in the Boone area, and ten van routes throughout the county. If you do not see your courses on AsULearn

- 1. Ensure you are looking under the correct tab under Course Overview (main page) (for example-"Future")
- 2. Access is provided approximately 2-3 weeks after your contract is signed and returned.
- 3. AsULearn pages from previous semesters should be saved for 25 months.

Making a backup of each course from previous semesters and downloading the course backup (.mbz) file to a local drive means you'll always have easy access to your course backups should they fall outside of that 25-month period.

Reminders

1. To make changes, add documents, etc. (Gear top right, "Turn editing on")

2. Make the course and gradebook "visible" to students after you have added your course material.

3. News & Announcements (emails) DO NOT go to students unless the course is VISIBLE (top right).

Announcements

Quick Mail

Allows you to send email messages to individual students, groups or the entire class, whether or not the site is available to students.

Help Page Video Guide

Metacourse allows you to group all the students in several sections together.

Click Participants (left column) Choose Gear Icon-Enrollment Methods Add Method-Metacourse Search and add sections-ensure they are all the same course, in the same half of the semester. Add all the section numbers in the title of the page to avoid confusion.

Meta Links (change spring 2020)

If you have used meta links in the past to consolidate multiple sections into one site, you may have experienced frustration with groups. You may have created all your groups one day, only to have students add your course the next, and then you had to manually locate the folks not in groups and get them placed. We felt your frustration, and our programmers worked to create a solution called, metagroup sync. Now, when students add your classes, they can automatically be added to a group with our new "Metagroup sync' option.

This will enter zeros for all the students who have not submitted work to an activity. This is important because if the grade is a "-" instead of a "0", the student's grade will not calculate correctly.

Attendance policy relating to participation in university-sponsored activities

As an integral part of the academic program at Appalachian State University, the University sponsors and otherwise supports co-curricular programs, athletic programs, and other out-of-class activities such as field trips. Participation in such activities occasionally requires a student to miss one or more class meetings.

A student who expects to miss one or more class meetings because of participation in a University-sponsored activity has several responsibilities: the student (in person) will notify the instructor in advance of any absence; the student is expected to complete all work missed by making up the work in advance or by completing any compensatory assignment that may be required by the instructor; the student is expected to maintain satisfactory progress in the course; and the student (otherwise) is expected to maintain satisfactory attendance in the class if so required. If a student anticipates that participation in a university sponsored activity will require missing more than 10% of the class meetings, the student is required to discuss this matter with her or his instructor at the beginning of the semester and may be advised to drop the course.

If the above responsibilities are met, it is expected that the instructor will excuse the absence and permit the student to make up missed work in whatever manner the instructor deems appropriate.

Early Attendance Alerts. See also Early Intervention Team

Anytime during the semester, but particularly at the beginning, if you become concerned that a student has incurred too many absences and is unresponsive to your attempts to contact them, faculty are encouraged to refer them to Academic Advising and Student Success. Appalachian Policy

6.3 Student Absences from Class

6.3.1 General Attendance Policy 6.3.1.1

It is the policy of Appalachian State University that class attendance is an important part of a student's educational experience. Students are expected to attend every meeting of their classes and are responsible for class attendance.

Since attendance policies vary from professor to professor, students should refer to the course syllabus for detailed information. Regardless of what reasons there may be for absence, students are accountable for all academic activities, and faculty may require special work or tests to make up for the missed class or classes.

In addition, faculty members are required to make reasonable accommodations for students requesting to miss class due to the observance of religious holidays. All App students are allowed a minimum of two absences per year for religious observances. Up to two absences for such observances will be excused, without penalty to the student, provided that the student has informed the instructor in the manner specified in the syllabus.

Notice must be given by the student to the instructor before the absence occurs and no later than three weeks after the start of the semester in which the absence(s) will occur. Arrangements will be made to make up work missed by these religious observances, without penalty to the student. For the purposes of this policy, ASU defines the term "religious observance" to include religious holidays, holy days, or similar observances associated with a student's faith that require absence from class.

Faculty, at their discretion, may include class attendance as a criterion in determining a student's final grade in the course. On the first day of class, faculty must inform students of their class attendance policy and the effect of that policy on their final grade; both policies must be clearly stated in the class syllabus.

A student who does not attend a class during one of its first two meetings may, at the discretion of the academic department, lose her or his seat in that class. Further, if a class meets only one time per week—e.g., a laboratory or an evening class—the student must attend the FIRST meeting of that class or risk losing her or his seat.

6.3.1.2

A syllabus is to be prepared for each course and distributed at the first of the semester. The syllabus should include the following: an explanation of course goals and objectives, the name of the text and any other materials required of each student, the instructor's office hours, an explanation of how the grade is to be determined, and an explanation of any additional reading, papers, projects and examination which the instructor expects to give or assign.

6.3.1.3

Syllabi for courses taught in the present and previous semester should be on file in the departmental offices and should be made available to students who request them. These syllabi would indicate the structure of courses as they are being or have been taught.

6.3.1.4

If a student does not regularly attend an audited course, the instructor may request an administrative withdrawal grade to be assigned. Instructor should provide documentation to the Registrar with the recommendation.

6.3.1.5

The Student Health Services DOES NOT write medical excuses for students who miss a class for illness or injury. However, faculty may call Student Health Services at (828) 262-3100 to verify the day and time the student was seen. The nature of the student's illness or problem will not be divulged unless the student has signed the appropriate release of medical information.

6.3.1.6

Classes prior to a university break or a state holiday end with the student's last meeting time for the day preceding the break or holiday.

6.3.2 Attendance Policy Relating to Participation in University-Sponsored Activities 6.3.2.1 As an integral part of the academic program at Appalachian State University, the University sponsors and otherwise supports co-curricular programs, athletic programs, and other out-of-class activities such as field trips. Participation in such activities occasionally requires a student to miss one or more class meetings.

6.3.2.2

A student who expects to miss one or more class meetings because of participation in a University-sponsored activity has several responsibilities: the student (in person) will notify the instructor in advance of any absence; the student is expected to complete all work missed by making up the work in advance or by completing any compensatory assignment that may be required by the instructor; the student is expected to maintain satisfactory progress in the course; and the student (otherwise) is expected to maintain satisfactory attendance in the class if so required. In the event that a student anticipates that participation in a University-sponsored activity will require missing more than 10% of the class meetings, the student is required to discuss this matter with her or his instructor at the beginning of the semester and may be advised to drop the course.

6.3.2.3

If the above responsibilities are met, it is expected that the instructor will excuse the absence and permit the student to make up missed work in whatever manner the instructor deems appropriate.

6.3.3 Emergency Absences.

When a student is out of town and unable to return to campus due to hospitalization, death in the family, or other extenuating circumstances, the student or the student's parents may contact the Office of Student Development to request that professors be notified as to the reason for the absence. This notification is conveyed to the appropriate departmental office as a matter of information only and does not serve as an official excuse for class absence. Only individual faculty members make this determination, and documentation may be requested by the faculty members. The Office of Student Development does not provide this service when notification is received after the absence has occurred. Also, if a student is in town, that student is responsible for notifying the individual faculty members that she/he will be missing class. *Printable PDF of the Appalachian Attendance Policy:* http://academicaffairs.appstate.edu/resources/syllabi

Statement on Student Engagement with Courses

The following statement has been approved by Faculty Senate/Academic Policies & Procedures Committee. In its mission statement, Appalachian State University aims at "providing undergraduate students a rigorous liberal education that emphasizes transferable skills and preparation for professional careers" as well as "maintaining a faculty whose members serve as excellent teachers and scholarly mentors for their students." Such rigor means that the foremost activity of Appalachian students is an intense engagement with their courses. In practical terms, students should expect to spend two to three hours of studying for every hour of class time. Hence, a fifteen-hour academic load might reasonably require between 30 and 45 hours per week of out-of-class work.

When a faculty member cancels class, he/she should email the PEA Director within 3 working days of the missed class, even if another instructor fills in. It is not necessary to fill out the Alternate Instruction form. It is not necessary to send an email if the university cancels classes. In your email, please include the course details and how you will address making time up (another instructor filling in, extra journal entries...etc.).

Wellness Peer Educators: 10 nationally certified student health educators

They are available to come to your classes, halls, teams, club, floors or any student organizations/programs and present on various health issues! Some programs are already created, and some can be created and tailored to your objective. We need at least 2 weeks' notice and at least 8 participants (please give us 3 weeks advance for tailor/created programs). For each program we do have selective goals and objectives of what the specific programs are to

accomplish for your group that we can share with you. We also do evaluations after each session to make sure those goals and objectives are met.

Practicum Supervisors

At times circumstances arise the morning of class that might cause a practicum teacher to be unable to come to class. If the teacher is in the VG, the other supervisor can supervise both classes.

If the teacher is in the QC/Stadium or SRC MG that person can call/text one of the VG instructors, who will go to the QC/Stadium or SRC MG to fill in. Please include me in the text and ensure you let them know where the class is meeting. If this happens on a IERs day, communicate with Scott about possibly conducting the IERs in the subsequent class meeting.

Please save the mobile phone numbers of the other practicum supervisors and Scott Townsend in your phone. Consider also exchanging mobile numbers with your practicum teachers. The PEA Faculty Manual also has additional emergency phone numbers in it and is available on the RMPE website.

Students may audit any PEA course. Students do not receive credit toward financial aid, etc. if auditing. Audit forms must be emailed to the PEA Director (Edgar Peck) prior to the start of the semester (drop/add period). All fees remain the same. Audits do not receive a grade/credit. The grade will appear as AU on transcript.

Students who are auditing a course do not have to complete course assignments. However, they must participate in course activities during class time and adhere to the student code of conduct.

If a student does not regularly attend an audited course, the instructor may request an administrative withdrawal grade to be assigned. The instructor should provide documentation to the Registrar's Office with the recommendation.

Repeats: Beginning fall 2014 students are only allowed 4 career repeats of any course. If the student audits the course, it will not count as a repeated course.

Background Checks. See also Faculty Contract Procedures

Individuals (excluding students) who work as part of the University-sponsored programs or summer camps offered to pre-college age minors are subject to background checks. New faculty member background checks are initiated by Academic Affairs at the time the contract is issued, not by the department.

All new employees must complete the background check form prior to employment. Background checks may take up to 3 weeks, complete this form well in advance of expected start date. This includes course assistants and risk managers. In the 4th-5th week of the semester, faculty receive emails from students who are requesting permission to add second half PEA courses. Often the reason is because the student is failing a course, but if they drop, they will be below 12 hours (full-time status) so they want to add your course so that they can drop the other.

Faculty should not override the cap on courses and allow extra students in for several reasons. 1. We have fought hard to keep the course caps low so that the students have a good experience, and faculty are not overwhelmed with the amount of work. If we add students over the cap, this can result in the cap being higher

in the future. 2. There are often students on the waitlist for courses, these students have done the correct thing, and we do not want to skip over them. Hopefully the waitlist limits the number of emails you receive.

Here is a suggested response to emails from students requesting to be added. Thank you for your interest in this course. The course is full, and I cannot override the cap in this course. I hope you are able to enroll next semester.

If you may be dropping below 12 credit hours for this semester and have questions about how this will affect your financial aid, insurance, dorm status, etc. Please contact the appropriate office on campus. If you have enrolled in and paid for 12+ credit hours, dropping a course mid semester may not impact these areas.

(I suggest you do not list out reasons you cannot override the cap. This will only lead to more emails between you and the student as you debate whether these reasons are legitimate). If you feel the student is in dire need, have him/her email me and I will consider adding them to a second half PE course after considering the teachers load, equipment availability, room size, waitlist, and course cap.

<u>Classdat</u>.

Used by some instructors to temporarily store files so that students can access the files from the internet. These files are erased each year.

RMPE Chair (Fall 2023)

While COVID is no longer considered to be a medical emergency, it is definitely still around. So what should you do if a student reports that they have either COVID or have been exposed to someone who has COVID? The university does not have much in the way of official guidance at this point. Therefore, I think it is relevant to consult the CDC's guidance. The following two webpages outline how to respond if an individual has tested positive for COVID, and also how to respond if they've been exposed to COVID. I suggest sharing these resources with students who report either of those situations, and to be familiar with the guidance yourself so you can best work with affected students.

Isolation and Precautions for People with COVID-19 What to Do If You Were Exposed to COVID-19

There are a few things you CAN NOT do:

Faculty and staff are not authorized to prevent students from attending class and cannot make isolation or quarantine decisions for others.

Ask students if the students have been vaccinated.

Attempt to verify the student's diagnosis with Health and Wellness programs, Emergency Management, the Dean of Students Office, or any other university office for verification.

To share the student's protected health information, unless written consent is provided by the student.

Overall, I encourage you to work with students who are affected by COVID to the extent that your course structure and syllabus allow, just like you would with any other illness or university-sponsored absence. I hope this information is helpful. Please let me know if you have any questions or concerns.

<u>CPR/First Aid Certification</u>.

All activity course instructors should strive to maintain current CPR/BLS knowledge/certification. A Red Cross CPR recertification course is typically held alternative years in August for RMPE faculty. If instructors are unable to attend there are several other courses held on and off campus. Instructors should refer injured students to the ASU Police or Student Health Services. In any emergency call 911/campus police.

Dropping a Course.

1. Students are allowed a maximum of 4 drops during their academic career at ASU.

- A. Full Semester Courses-drops during first 5 days of the semester do not count toward the 4 career drops.
- B. First Half Courses-drops during the first 5 days of the semester do not count toward the 4 career drops.
- C. Second Half Courses-drops during the first 2 days of the second half do not count toward 4 career drops.

2. Drops beyond the Drop Date require a late drop permission.

- A. The "Last day to drop a first-half semester course" and "Last day to drop a second-half semester course" dates are listed on the Registrar's calendar (approximately 4 weeks after the start of class).
- B. Students must request a late drop from the Instructor, PEA Director, RMPE Chair, and Dean's office. Late

drops are usually only for extenuating hardship circumstances.

C. Students who have already used their 4 drops, can request a Dean's over-ride to allow another drop. Again, usually only approved in hardship circumstances.

Medical Withdrawal: For students who cannot complete a course due to injury or illness.

1. Student takes his/her medical information and course information to Student Health Services (262-3100) requesting a medical drop. If the request is granted, paperwork will be presented to Student Services Area in the Registrar's office (JET Building). This drop will not count as 1 of the student's 4 career drops.

To request a Medical Withdrawal, sign in to the Student Health Medportal and then send Dr. Taylor Rushing a message detailing that you are requesting a Medical Withdrawal because you cannot continue in your PEA course due to a medical/illness reason. Include the course number, course section, course name and course credit hours. You will also need supporting medical documents/information. Sending a message in the portal will create an electronic record.

Rafts, WW kayaks, FW kayaks, SUPs and accessories (PFDs, paddles, etc). Rock Climbing shoes. Instructors should plan to meet students at SRC OP to make loading easier. This also allows you to size students so you do not need to take extra PFDs etc. which might be needed by other PEA, RM, OP trips. Follow the preplanned schedule for picking up and dropping off gear. Do not use PFDs marked "rental".

There is 1 key for all RMPE faculty to use to access equipment cages. Located on cages in the lounge. Hang up wet gear. There are two rolling racks that can be used for PFDs. There is a schematic of the bay in the RMPE mailbox in SRC OP.

RMPE Outdoor Gear

Stoves, pots, backpacks, trekking poles, single tents, (which are not great), cooking tarps, etc are in HCC 82 (inside classroom 83). You can get fuel from Edgar or Joshua.

Trailers (See also Vehicles)

Box trailers are available. There are limited vans with trailer hitch receivers at the motor pool. To ensure your van has a trailer hitch receiver you need to write it in on the Travel Authorization/Vehicle Request form and call to confirm the week prior. The hitches are locked onto Motor Pool vans, ensure the hitch is 2" in advance. Wire adapters are in each trailer and in the RMPE Van.

Inside each box trailer is a 2" ball and hitch, hitch lock, wiring harness adapter, spare tire, and tool box. The vehicle registration is inside the box trailer. Please use the hitch lock to lock the trailer to the van/truck. Report loss of items so they can be replaced before the next trip. Hitches also located in the RMPE Truck and Van.

Trailers have been moved fall 2019 to the old freshman lot located below the Physical Plant (State Farm). They are located directly behind the Intramural fields. Canoes and rack have been moved to State Farm Fall 2023. No equipment remains in the surplus lot.

1. Appalachian's RMPE PEA Program continuously recruits qualified individuals to fill adjunct faculty positions. Instructors must hold a minimum of a bachelor's degree. Potential faculty should email a current resume, a letter of intent, and 5 references (name, position, phone number) to the PEA Director.

2. Hiring paperwork: The PEA Director submits to the department a file containing the following so that a Dean's Rec can be completed by the RMPE Administrative Assistant.

Employee's full name/ local address (banner ID)

List of courses and hours teaching

Resume/Certifications copies (Resume should list AppState as most recent employer-start Sp 2024).

Credentials Justification paragraph when applicable

Official Transcripts

For Appalachian State transcripts: send an email to <u>transcripts@appstate.edu</u> requesting transcripts for employment at ASU for a new hire. If the hiring department requests the transcript there is no charge. Transcripts will be sent via campus mail-transcripts cannot be sent electronically.

3. Background checks are completed by Academic Affairs and HR after the Dean's Rec is complete.

4. Faculty should work with the director to verify completion of CPR and the Wellness Literacy modules.

5. Current AppState full-time employees can teach courses outside of normal working hours with permission of his/her supervisor. Permission email from instructor's supervisor, the PEA Director, and RMPE Dept. Chair is attached to the Dean's Rec submitted by the RMPE Dept. This should be done each semester. These instructors may receive a \$0 contract, or regular payment, depending on their status.

Contact Academic Affairs with a list of all full-time App employees from other departments teaching each semester ensuring that they are entered into the system with NO CONTRACT END DATE to ensure their email/information is not deleted at the end of their teaching duties.

6.Graduate students need permission from the graduate school Associate Dean to teach courses. Graduate students can be paid as adjuncts or on a GA/TA. The minimum GA is ½ (10 hours). 10-hour GA=3 credit hours. Attach permission from Associate Dean of Grad School stating the student is in good standing, including name, banner ID to the Deans Rec.

7. The maximum number of credits an adjunct can teach in one year is 17 hours. Adjunct faculty cannot work hours as non-student temps (Risk Managers) in addition to 17 hours. After the Dean's Recommendation is approved at the college level, Academic Affairs mails a contract, bio sheet, and background check form, to the instructor. Instructor signs and returns it to Academic Affairs in person, or by mail.

If contract is not written and signed before May 31 the instructor's email and system access is sometimes suspended. Contracts are emailed to personal email address (2021).

8. After returning the contract, the instructor should complete I-9 tax paperwork at Human Resources in person. See Human Resources above for address.

9. After the contract is processed by Academic Affairs (usually 1-3 days) the instructor can obtain a parking pass and ID card (you will need a copy of your contract/email or a letter from the RMPE administrative assistant). PEA Director adds the instructor to their courses in Banner (gain access to Appalnet, AsULearn, rosters...) after they have been entered in the system.

10. Instructor is added to the Kendall Hunt Wellness Literacy website by the PEA Director.

11. Instructors wishing to use UREC facilities must fill out a membership form each semester at the Student Rec Center or ID Center. Instructors who teach in these facilities, but do not want to join should contact the PEA Director so their name can be added to the sign in list. Adjuncts are now eligible for family memberships.

12. Adjunct faculty are not required to attend the new faculty orientation.

Grades must be submitted by before the date set by the Registrar. An email will be sent to notify all faculty. This is not an artificial institutional deadline. Failure to submit student grades has real consequences. Among other things, grades have to go on transcripts sent to employers or graduate schools; grades determine academic standing to continue at Appalachian; and grades affect eligibility for financial aid. We simply cannot have large numbers of student grades undetermined as we move into spring semester.

Transportation is a critical constraint. Approximately one-third of students depend on Appalcart, and the university does not control Appalcart schedules. If Appalcart determines that it is too dangerous to run buses, we immediately have a situation in which large numbers of students likely will miss exams.

Travel plans are often made months in advance by students and faculty. While travel plans often can be changed, alterations to flight schedules, for example, tend to be costly and inconvenient. If adverse weather interferes with final exam schedules, instructors should make every effort to provide reasonable accommodations for students with travel plans.

Faculty members can help minimize the impact of adverse weather or exam session cancellations by developing contingency plans for online examinations or assignments in place of an in-person final exam. Learning Technology Services (LTS) can assist faculty in developing alternatives. Ideally, faculty members should plan ahead to have an option readily available but help on short notice is also available. AsULearn is our official, university-wide, online environment. Some faculty members who routinely teach online distance education or hybrid courses will of course use their regular online environments.

Grading Basics

A. You are not responsible for emailing students if they fail to turn in an assignment or miss class. If you want to remind students about assignments or absences, do it in person in class.

B. Students cannot pass the course without completing and passing 3 Wellness Literacy modules. Change fa22.

C. Failure to complete assignments is NOT a reason to record a grade of Incomplete (see below).

D. You can prevent individual student emails by posting an announcement listing the date you will post grades.

E. Submit official grades in Appalnet: Directions for noting last date attended, and documenting students who never attended are listed in Appalnet on the final grades screen.

F. If you need the last day attended for an online course you can click on participants (top left side) to see the last day the student visited AsULearn.

Grades and Grade-Point Average

The grade-point average (GPA) is a general measure of the student's academic achievement. The GPA is determined by dividing the total number of quality points earned by the total number of quality hours attempted ("quality points" and "quality hours" are derived from courses graded A–F or WF). The GPA is computed only on the basis of coursework taken at Appalachian. Undergraduate grades and grade points are given as follows:

- A Excellent 4.0 grade points per semester hour
- A- Excellent 3.7 grade points per semester hour
- B+ Above Average 3.3 grade points per semester hour
- B Above Average 3.0 grade points per semester hour
- B- Above Average 2.7 grade points per semester hour
- C+ Average 2.3 grade points per semester hour
- C Average 2.0 grade points per semester hour
- C- Average 1.7 grade points per semester hour
- D+ Below Average, but passing 1.3 grade points per semester hour
- D Below Average, but passing 1.0 grade point per semester hour
- D- Below Average, but passing 0.7 grade point per semester hour
- F Failing grade 0.0 grade points
- AU Audit, no credit
- I Incomplete, assigned only because of sickness or some other unavoidable cause. *An "I" becomes an "F" or "U" if not removed within the time designated by the instructor, not to exceed one semester, except that all incompletes must be removed at the time of graduation. An Incomplete is not given merely because assignments were not completed during the semester.*

Incomplete

Grades of "I" incomplete are to be assigned ONLY because of sickness or some other unavoidable cause, not merely for missed assignments. The instructor should enter "I" as the grade. The instructor should notify the student in writing a timetable for completing the required work and outline exactly what is expected (attendance, assignments...). Work must be completed by the end of the next semester. If part of the make-up work is to attend a course during the next semester, the student will not reregister for the course.

Grade Appeal Procedure.

The PEA Director should be informed by the instructor of students who express grade disputes/issues. Student Grade Questions

A. We should welcome questions about grades from students because we want students to understand how their grade is calculated and we want students to be engaged.

- B. If a student has a question about their grade a good starting point is often to email them a breakdown of each assignment grade with a short summary explanation about where they lost points.
- C. Please contact the PEA Director to talk through these situations.
- D. If the student expresses a desire to appeal the grade your first step is to email them the PEA Director name and contact information (CC PEA Director on the email to the student). Do not refer students to the RMPE Chair, Dean, Appeals Committee, etc.

Grade Appeal Procedures/Form: www.academicaffairs.appstate.edu/

Any student considering a grade appeal should understand that each faculty member has the right and responsibility to determine grades according to any method chosen by the faculty member which is professionally acceptable, communicated to everyone in the class, and applied to all students equally. Prejudiced, arbitrary, or capricious academic evaluation by a faculty member, however, is a violation of the student's rights and is a valid ground for a final grade appeal.

Steps to take in final grade appeal

Any student who contests a course final grade shall first attempt to resolve the matter with the instructor. The student must explain her or his position to the instructor and attempt to understand the instructor's reasons for assigning the grade. The purpose of the meeting is to reach a mutual understanding of the student's situation and the instructor's actions and to resolve differences in an informal and cooperative manner. If the student fails to reach a satisfactory solution in consultation with the instructor, the student must present the appeal in writing, using the grade appeal form, to the chair of the department in which the contested grade was awarded. A copy of the necessary form is provided at the end of this document.

The student must file the written appeal with the department chair within 14 calendar days after consulting with the instructor.

The statement must be specific and concise and limit itself to citations of evidence pertaining to valid grounds for the appeal. Through conferring with the student and the instructor, the chair will seek resolution by agreement. The student must provide the chair with a course syllabus and all available tangible materials related to the grade (e.g., exam and term papers) as well a list of any items used in the evaluation for which the student cannot provide documentation (e.g. Unreturned exams, grades on class participation, attendance records).

If there is failure to reach an agreement through consultation with the chair, the student may file the written appeal with the Grade Appeals Committee through the Office of the Dean of the college or school in which the grade was awarded. The student must file this written appeal within 30 calendar days after the beginning of classes in the next semester after the contested grade was awarded.

When possible, the form must be signed and dated by both the instructor and the department chair as well as the student. In accordance with the instructions on the form, the student must present with it the documentary evidence furnished to the department chair and any other evidence relevant to the case.

The dean or her or his designee serves as convener of the Grade Appeals Committee of the college or school. Each full committee consists of the convener (who presides over hearings), the chair of the department in which the contested grade was assigned, three faculty, one undergraduate student, and one graduate student, all from the college or school which the committee serves. The department chair sits in a non-voting capacity, and the convener votes only in the case of a tie. The three faculty members, one alternate faculty member, and two students are appointed by the dean from among volunteers for the assignment. A quorum for each committee shall consist of no less than one student and two faculty members, along with the convener.

The Grade Appeals Committee has authority to screen out frivolous or unsubstantiated appeals. The convener will explain any such finding in writing to the student, the faculty member, and the dept. chair. If the committee grants a full hearing, the student will appear before it to present all evidence relevant to her or his case. The convener will also invite the instructor to appear and present any evidence in support of her or his grade decision. The committee may ask questions of either or both and will hold its deliberations in executive session after hearing the case. The dean, the department chair, the faculty member and the student will receive prompt written notification of the committee's findings. The committee's decision is binding. If the committee supports the student's appeal, the instructor will be required to re-evaluate the student according to a specific method. The method of reevaluation will depend on the circumstances of the appeal. Reevaluation will not be used in a punitive manner toward the student. The student has 14 calendar days to inform the instructor, department chair, and convener in writing whether she or he consents to the proposed method of re-evaluation (which must be completed within the semester of the finding). Should the student not consent to the proposed method of re-evaluation, the instructor, chair, and committee will mutually agree on a method of recalculating the appealed grade. In either case, the resulting grade is final and may not be appealed.

Instructional Assistant (Team Teaching)

Any person who is assisting the instructor of record teach a physical education course should be documented with the following procedures. *This includes instructors/assistants not paid*.

Non-Students

The procedure for hiring an assistant instructor is virtually identical to placing an Instructor of Record under contract. The assistant should contact the PEA Director to complete the Dean's Recommendation/Contract.

Students

Experienced students can be extremely effective as classroom assistants. Students can receive elective physical education course credit for assisting. Paperwork is available at the HCC front desk. You need the "Instructional Assistant Form" **AND** "Special Course Form". Contact the PEA director if you have questions. *The Special Course form is available electronically on the Registrar's website.*

The instructional assistance program is designed for students interested in participating, for academic credit, in supervised experiences in the instructional process on the University level through direct participation in classroom situations.

Students with junior or senior standing are eligible to participate in this program. An undergraduate student may include a maximum of 3 semester hours credit under the Instructional Assistance Program toward meeting graduation requirements.

Procedures

Course form to the Registrar, who will register the student. Note: the course is PE 3520 (NOT the PEA course # assisting with). The course title is "Instructional Assistant". Section can be left blank. Please list the part of term (first half/second half/full semester). List the meeting days/times for the course which the student will be assisting with.

Part-time instructors can elect to be paid by direct deposit. Fill out the Direct Deposit form in Human Resource Services, or from the HRS website, attach a voided check, and return to HRS-Kathy Hamby (262-6485). www.hrs.appstate.edu/forms/employment/checkdeposit.pdf

Instructors who sign their contracts prior to the beginning of the semester are typically paid over the course of the whole semester. This is typically five (5) payments, usually 2 at the end of the first month, then 1 at the end

of the next 3. Fall example: Two payments at the end of Sept, 1 at the end of Oct, 1 at the end of Nov, and 1 in the middle of Dec because of the holidays.

Instructors who are full-time employees in another area on campus are typically paid via a onetime pay form at the end of the semester. These employees will receive the total amount in the final pay period of the semester. Employees who would like correspondence from HR (like your W2) mailed to their home address instead of the RMPE Department (HCC) mailbox should contact Cindy Harper in HRS (262-6487). Let Cindy know you would like to change your check distribution address so that payroll will send the check to your home. You can confirm that your address is correct on Appalnet, Self Service tab.

Summer Pay:

Summer pay is considered "one time" pay and is taxed at a different rate than "annualized" year round pay. This may result in your net pay to be significantly lower during times you are paid "one time."

Pay Direct Deposit Information Online Using Employee Self Service

Effective July 2010 payroll, all Appalachian employees currently on direct deposit and receiving paper stubs will now have the advantage of viewing their direct deposit info online using Employee Self Service. There are many benefits to receiving your direct deposit stub online. An electronic view of pay information provides timely, simultaneous delivery of pay data to all employees. This method offers the ability to view and print current as well as prior direct deposit stubs. Employees can preview or access current earnings info, including taxes, deductions, year-to-date totals and distribution of net pay, 3 days prior to each payday.

To view your direct deposit information online do the following:

- iv) Pay Stubs

- v) Select Year
- vi) Click Display
- vii) Click Date Link for Desired Pay Stub
- We also wish to remind University employees of the Direct Deposit requirement, which ensures timely deposits into your bank accounts on the morning of payday. Students should contact the Payroll Office to set up direct deposits, and all other employees should contact Human Resource Services to set up this service. Students are only allowed 4 career repeats at Appalachian. Students cannot receive credit for the same course twice. The most recent grade counts toward GPA, not the highest. Repeat problems are often associated with Skiing/Snowboarding. They sign up for beginning, then want to be switched to Intermediate because they already took beginning. Switching students in skiing after the start of the spring semester is a bad idea, and makes it difficult on bus drivers, FSSS, etc. See below, students have received multiple emails from the registrar telling them they need to switch way before the start of the semester.

When repeating a course students will receive an email

Risk Managers.

In outdoor activities courses that require students to be more than 1 hour from definitive medical care, at least one University Employee with Wilderness First Responder (or above) training must be present. This employee can be the Instructor of Record or "Risk Manager".

Supervision Requirements for Off-Campus Class-Related Educational Experiences (Effective: Fall 2012) **Industry standards should be followed at all times. In addition:**

- A. **Outdoor Adventure Activities within One Hour of Definitive Care:** Require supervision by an ASU employee. First Aid Kit required.
- **B.** Outdoor Adventure Activities More than One Hour from Definitive Care:
 - 1. Require two ASU employees OR 1 ASU employee and a contracted professional(s)
 - 2. One leader must hold a current CPR certification and a current medical training license/certification
 - at the Wilderness First Responder or higher level (i.e. EMT/Paramedic/Physician). First Aid Kit req.

Risk Manager Job Description/Function: This Appalachian employee assists the course instructor with risk management during a trip that takes students to an off-campus location, which is more than one hour from definitive care. Duties may include helping the instructor/trip leader identify potential risks, analyze them, and take precautionary steps to reduce the risk of injury when possible. Duties may also include providing medical care during an emergency or accident.

Risk Manager Qualifications: Minimum Qualifications-Knowledge of CPR and first aid techniques. * ***Preferred Qualifications:** Wilderness First Responder or higher certification (i.e. EMT, Paramedic).

Risk Manager Pay (\$11-\$13 per hour-typically \$12hr)

Beginning fall 2014 risk managers will now be paid for UP TO 16 hours per day on a day they spend the night. Working over 8 hours in a day is allowed, but RM should work less than 40 hours during the two week pay period. Risk managers must fill out a timesheet online AND submit a paper timesheet to the RMPE Department.

Timesheets

Fill out paper version:

For work 1st-15th of month-due by 5pm on 15th or first working day if trip lasts through weekend. For work 16th-end of month-due by last day of the month or first working day if trip lasts through weekend

REMEMBER: You have to fill out the timesheet online AND hand in a signed printed copy.

1. Sign into BANNER Self Service to access electronic timesheet, enter appropriate time-submit for approval. 2. Fill out the paper time sheet to match what was submitted and worked, sign along with your direct supervisor and submit to RMPE Admin. Assistant. Turn in directly, slide under office door, place in mailbox, or email it.

Risk Managers/Temporary Employees Procedures

Risk Managers must be approved by the RMPE Department each semester, even if the risk manager worked during the previous semester. Contact the RMPE office (HCC 42), 262-3149 each semester to renew your paperwork as an approved "Risk Manager". Paperwork must be completed at least 2 weeks prior to the "trip".

Risk Managers must complete the required paperwork PRIOR to working. It is the course instructor's responsibility to ensure the Risk Manager has completed the paperwork. Risk Managers must submit signed timesheets to the RMPE Office.

Risk managers who are not current ASU students are categorized as "Non-Student Temp" employees.

- 1. Background Check required
- 2. Online Application
- 3. HR Packet/I-9 Forms/Background checks completed in HR packet.
- 4. Driver's license and travel authorization copies will be kept on file in the RMPE department.

Student Employee

Must be hired 4-7 days before the first trip

Have the student fill out the packet attached, bring it to RMPE admin to sign, and fill in the Budget codes. The student will need to take this to the Student Employment office. If the student has not worked on campus before they will need to complete tax paperwork and provide 2 forms of ID.

Non-Student Temp. (who has worked for RMPE as NST in the last year)

Must be hired $1 \frac{1}{2}$ weeks before the first trip Email RMPE admin requesting a renewed hire. Renewals can be for 1 Year of Employment.

SDAP student registration is typically coordinated with the PEA Director. PEA faculty should be notified by the director if they have a SDAP student in their course(s).

SDAP students typically Audit courses (do not receive a letter grade). SDAP students DO want to complete as much of the coursework as possible and DO want to fully participate in the class activities. Instructors should make modifications/extension available to make this possible. They often do NOT complete the Wellness modules. Often SDAP students have an assistant with them in class (important to note for courses using a van).

<u>Student Assault/Trauma</u>. See Emergencies, Counseling, Early Intervention, Stud. Referrals.

There may be times when a student reports an assault/trauma to you. All AppState faculty undergo training. Note that faculty are mandatory reporters. Contact your program director and/or the department chair for further guidance immediately. A few guides are below.

1. Try to let the student know you are a mandatory reporter before they disclose information so the student can make their own choice about what to disclose.

2. Listen

3. Try not to assume you know what will help. Ask: Are you physically safe right now? Ask: what can you do to help? Ask questions: they might have different resources than you, need different things that you might. How do they feel? Ask if the person if they want you to share resources.

3. Help folks make small steps. Share resources when appropriate. Know if resources are confidential.

4. Three Step Plan

ID Support systems (family, friends, groups)

Explore coping strategies (self-care, soothing, what helps you stay calm, where do you feel safe) Locate Resources (Counseling Center, Crisis Hotlines, OASIS, Title IX Office...)

5. Resources

Counseling Center (confidential, supportive) OASIS (off-campus support, confidential, supportive) Title IX Office (investigative-similar to law enforcement)

MAP-Works

MAP-Works allows us to identify concerns about students who are having mild transitional issues and provide timely and targeted support to them.

Instructors say they use MW to

- o learn more about areas in which students are struggling,
- o help students link their behaviors and habits to their academic outcomes,
- create central referrals so student with academic or mild transitional needs can receive assistance from the appropriate support office(s) on campus, and
- o send emails of recognition to students who are working especially hard or going the extra mile

If you instruct first-year students (freshmen or transfer), you already have access to MAP-Works. To access your MW account, go to <u>map-works.appstate.edu</u> and use your App credentials to log in. Start by going to the "Student Tracking" tab. A number of functions can be completed from this page by clicking on any student's name and selecting your desired function from the drop-down menu.

Selecting the "Activity" button from the drop-down menu mentioned above, choose "View All Activity." From this screen you can

- email student and their instructors with accolades or kudos for exemplary effort or performance
- o enter concerns/referrals to others on campus (Central referrals sent to MAP-Works Coordinator)

By choosing the "Dashboard" option from the same drop-down menu, you can learn a lot about your students' transition to University life. Feel free to explore the program and click around.

Syllabus.

The PEA activity course syllabus template is reviewed and modified periodically. Please check carefully to ensure you are using the current version. Templates are available on the RMPE website (Faculty & Staff).

Syllabus Elements

1. Fitness Tests/Goals

Fitnessgram will be used whenever possible, other tests can supplement these assessments.

Assessments can be conducted as a one or two times.

Use the personal fitness goals directions/assessment tool provided, modify as needed, or make your own.

2. Personal/Social Responsibility

Use the Responsibility Assessment Tool scale on the syllabus as a guide.

Record student's behaviors in the class record book when relevant. If reducing points, talk to the student about their behavior so they have an opportunity to correct it/improve.

3. Journal/Log

Use the Journal/Log assessment tool example provided, modify as needed, or make your own.

4. Skill Assessments

Choose 2-5 skills you think are most important to assess. Keep it simple. Using stations may be an effective/quick method for assessing skills. Practice assessing the skills throughout the course (formative). Complete a final assessment near the end of course for a grade (summative). Skills can be assessed during game/activity over a several week period for authentic assessment.

5. Written Exam

This should measure the knowledge you think is important to participate in the activity. Modify the syllabus template and AsULearn description to reflect the type of exam you are administering. Providing students written notes and other material will improve their knowledge, understanding, and grades. The Kendall Hunt Activity Module exams allow two (2) attempts.

6. Wellness Literacy

Fall 2022: Students no longer fail the course if they do not complete the wellness literacy modules. They do lose the points. Completion of Gen Ed Wellness Literacy in another course has nothing to do with whether they complete this assignment to earn these points. See Wellness Literacy section for more information.

7. Record of Attendance

Record when students are present/absent, and when they are late in the class record book. Faculty should consider requiring prior notice of an absence if he/she allows students to make up points.

8. Late Work Policy

Modify this section to describe your policy. Be cautious about giving students 0 points for late work, if they do not do the assignment, they do not learn.

9. Medical Information form (change 2020)

Only students who have a medical concern need to fill out this form. Instructor should use information to modified activities when possible, to reduce further injury.

In cases of serious disability/condition inform the PEA Director.

Courses more than 1 hour from definitive care should use the RMPE in depth medical form.

Wellness Literacy Transfer Students

Any student transferring PE ACTV (PE activity courses) from another institution must complete three modules for each transfer course in order for that course to count for General Education Wellness Literacy. Students who transfer in two+ courses should complete all six modules.

Change-transfer students entering Appalachian summer 2017 or after do not need to complete the modules for their PEACTV courses to count. Athletics, even if given PEA credit, do not count for Appalachian Wellness Literacy credit.

Transfer students receive a standardized email from the PEA Director, sent by Melissa Hicks in the Registrar's Office a week after the semester has begun. Director must contact Melissa to request email be sent each semester. 4.4.2 Definition and Titles

4.4.2.1 A part-time faculty member is defined as a person with a faculty appointment and whose workload is less than 12 semester credit hours or the equivalent per semester.

4.4.2.2 Appointments may be made to fixed-term faculty ranks with title designations including, but not limited to, "lecturer," "artist-in-residence," "practitioner-in- residence," "writer-in-residence," and any of the faculty rank designations provided in sections 3.4.2.4 through 3.4.2.7 with the prefix-qualifier "adjunct," "clinical," or "research," under the conditions and with the incidents herein provided. Such an appointment characterized by any of the foregoing title designations is appropriate for one who has unusual qualifications for teaching, research, academic administration, or public service but for whom neither the professorial ranks nor the instructor rank is appropriate because of the limited duration of the mission for which the appointment is made, or because of concern for continued availability of special funding for the position, or for other valid institutional reasons (see section 3.4.2.8).

4.4.2.3 Titles under which part-time faculty are appointed can be found in section 3.4.2.8. The vast majority of part-time faculty are appointed at the rank of lecturer or adjunct instructor.

4.4.3 Terms of Contracts

4.4.3.1 The terms and conditions of each appointment to a part-time faculty. *Faculty Handbook* – Chapter IV – 09/18/09 – Page 74 position shall be set forth in a written contract. A copy of the contract, including rank, salary (when possible), and contract date, signed by the Chancellor or the Chancellor's delegate, shall be delivered to the faculty member. Contracts for part-time faculty are for fixed terms and may range from one semester to five years. Any special terms and conditions shall be clearly stated in the contract. The chair or dean who recommends the appointment shall be responsible for initiating the inclusions of special terms and conditions in contracts.

4.4.3.2 Initial appointments may be for a fixed term of up to three years. Subsequent appointments to fixed terms of from one to five years' duration may be made either in direct succession or at intervals. Each shall be considered an initial appointment. This institution shall not be obliged to give any notice before a current term expires as to whether appointment will be offered for a succeeding term (see section 3.4.2.8).

4.4.3.3 Part-time faculty will share with full-time faculty all rights guaranteed under the concept of academic freedom and all responsibilities as defined in section 3.3, entitled "Academic Freedom and Responsibility of Faculty."

4.4.3.4 Part-time faculty teaching more than six (6) hours per semester have the right to hold faculty offices and to vote in general faculty meetings, meetings of departmental and college/school committees on which they serve, and faculty elections, with the exception of election of members to departmental personnel committees, as stated in Article II, Section 2. and Section 3. of the Faculty Constitution.

4.4.3.5 During the period of their employment, part-time faculty shall have full access to benefits of the dispute resolution processes outlined in section 3.9 of this *Faculty Handbook*.

4.4.4 Benefits

The policy of the State of North Carolina is such that part-time faculty must have a workload of nine hours or the equivalent per semester and have a contract for an academic year in order to be eligible for benefits (see Chapter VIII). Part-time faculty with a contract of shorter duration are not eligible for such benefits as health coverage, disability salary continuation plan, group life and other insurance plans (see Chapter VIII).

4.4.5 Services

4.4.5.1 Part-time faculty are eligible for the following services listed in Chapter VIII, sections 8.6, 8.7 and 8.8: Auxiliary Services, University Bookstore, AppCard Office, Food Services, Controller, and Administrative Services. Part-time faculty are also eligible for all services provided by the State Employees Credit Union.

4.4.5.2 Current part-time students, faculty, instructors, adjunct faculty, staff and temporary employees are allowed to use recreational facilities. Their dependents and spouses are NOT eligible to use the recreational facilities and to obtain an Appalachian State University ID card. *Faculty Handbook* – Chapter IV – 09/18/09 – Page 75 (typo)

4.4.6 Salary Checks

Part-time faculty salaries are paid in accordance with the schedule outlined in the employment offer contingent upon the completion of all appropriate forms and documents.

4.4.8 Parking

4.4.8.1 Part-time faculty are eligible to receive a campus parking permit. Vehicle registration fees may be payroll deducted. For a copy of the *Appalachian State University Parking and Traffic Regulations*, go to: http://www.parking.appstate.edu.

4.4.8.2 Faculty with semester contracts will also have the option for payroll deduction. This deduction will be taken out in three installments for semester or year permits (no refunds). To be eligible for payroll deduction a faculty member must obtain a form from the appropriate dean and bring it to the University Parking and Traffic Department to fill out the necessary paperwork.

5.7 Student Discipline

Members of the faculty should report general disorderly behavior and student misconduct to the Director of Student Judicial Affairs in the Office of Student Conduct. Students should report similar cases to the Director of Student Judicial Affairs.

Procedures for dealing with general student disciplinary matters are addressed in the Appalachian State University Code of Student Conduct. Procedures for dealing with cases of academic misconduct (such as cheating, plagiarism or fabrication of data, etc.) are addressed in *Faculty Handbook* – Chapter V – 09/18//09 – Page 106

In cases of student misconduct in the classroom, laboratory, or other class setting, the instructor may immediately require the student in question to leave the classroom and at the close of class, the instructor should notify the Director of Student Judicial Affairs in the Office of Student Conduct. The instructor has the right to temporarily exclude a student from a class for disruptive behavior until the situation is dealt with and resolved in a timely manner. If the instructor plans to initiate disciplinary proceedings against the student, the instructor will submit, in writing, a statement of fact regarding the incident. Members of the faculty may choose to contact the Appalachian State University Police Department in cases of student misconduct when students are disruptive or disorderly. Appalachian State University's Academic Integrity Code sets forth the standards of academic integrity at Appalachian State University and describes attendant responsibilities for faculty and students.

5.13 Final Grades

5.13.1 Reporting Final Grades

Final semester grades are reported to the Registrar's Office no later than 1:00 P.M. on the day following the Faculty Grading period. At the end of each semester, the student's grades are available via AppalNET or from the Telephone Registration System. (Note, however, that North Carolina law prohibits the release of grades, transcripts or diplomas to students with unpaid accounts.)

Faculty members who cannot meet the final grade submission deadline should contact the Registrar's Office for an extension of time for reporting grades.

5.13.3 Final Grade Appeal Procedure

5.13.3.1 Any student considering a grade appeal should understand that each faculty member has the right and responsibility to determine grades according to any method chosen by the faculty member which is professionally acceptable, communicated to everyone in the class, and applied to all students equally. Prejudiced, arbitrary, or capricious academic evaluation by a faculty member, however, is a violation of the student's rights and is a valid ground for a final grade appeal.

5.13.3.2 Steps to take in final grade appeal

(a) Any student who contests a course final grade shall first attempt to resolve the matter with the instructor. The student must explain her or his position to the instructor and *Faculty Handbook* – Chapter V – 09/18//09 – Page 110 attempt to understand the instructor's reasons for assigning the grade. The purpose of the meeting is to reach a mutual understanding of the student's situation and the instructor's actions and to resolve differences in an informal and cooperative manner. If the student fails to reach a satisfactory solution in consultation with the instructor, the student must present the appeal in writing (using the Grade Appeal Form) to the chair of the department in which the contested grade was awarded. [A copy of the Grade Appeal Form is available in Appendix E of this *Faculty Handbook* and at http://www.academicaffairs.appstate.edu/resources.]

(b) The student must file the written appeal with the departmental chair within 14 calendar days after consulting with the instructor. The statement must be specific and concise and limit itself to citations of

evidence pertaining to valid grounds for the appeal. Through conferring with the student and the instructor, the departmental chair will seek resolution by agreement. The student must provide the departmental chair with a course syllabus and all available tangible materials related to the grade (e.g., exam and term papers) as well as a list of any items used in the evaluation for which the student cannot provide documentation (e.g., unreturned exams, grades on class participation, attendance records).

(c) If there is failure to reach an agreement through consultation with the departmental chair, the student may file the written appeal with the Grade Appeals Committee through the Office of the Dean of the college or school in which the grade was awarded. The student must file this written appeal within 30 calendar days after the beginning of classes in the next semester after the contested grade was awarded. When possible, the form must be signed and dated by both the instructor and the departmental chair as well as the student. In accordance with the instructions on the form, the student must present with it the documentary evidence furnished to the departmental chair and any other evidence relevant to the case.

(d) The dean or the dean's designee serves as convener of the Grade Appeals Committee of the college or school. Each full committee consists of the convener (who presides over hearings), the chair of the department in which the contested grade was assigned, three faculty, one undergraduate student, and one graduate student, all from the college or school which the committee serves. The departmental chair sits in a non-voting capacity, and the convener votes only in the case of a tie. The three faculty members, one alternate faculty member, and two students are appointed by the dean from among volunteers for the assignment. A quorum for each committee shall consist of no fewer than one student and two faculty members, along with the convener.

(e) The Grade Appeals Committee has authority to screen out frivolous or unsubstantiated appeals. The convener will explain any such finding in writing to the student, the faculty member, and the departmental chair.

(f) If the committee grants a full hearing, the student will appear before it to present all evidence relevant to her or his case. The convener will also invite the instructor to appear and present any evidence in support of the instructor's grade decision. The committee may ask questions of either or both and will hold its deliberations in executive session after hearing the case. The dean, the departmental chair, the faculty member and the student will receive prompt written notification of the committee's findings. **THE COMMITTEE'S DECISION IS BINDING.** If the committee supports the student's appeal, the instructor will be required to re-evaluate the student according to a specific method. The method of re-evaluation *Faculty Handbook* – Chapter V – 09/18//09 - Page 111 will depend on the circumstances of the appeal. Re-evaluation will not be used in a punitive manner toward the student. The student has 14 calendar days to inform the instructor, departmental chair, and convener in writing whether she or he consents to the proposed method of re-evaluation (which must be completed within the semester of the finding). Should the student not consent to the proposed method of re-evaluation grade. In either case, the resulting grade is final and may not be appealed.
